Previously Opening Permission has been accorded to the classes VIII to X (EM) of **Dr.Varalakshmi High School, T.Boddavara, S.Kota Mandal, Vizianagaram District** in Proceedings L.Dis.No.RJDSEK-ADMN0PUAE (A3UA)/25/2018-JA-A3, Dt.25.7.2018 of the Regional Joint Director of School Education, Kakinada in the reference 4th cited. The Correspondent has submitted the application for Provisional Recognition for the classes VIII to X (EM) in the school for the years from 2018-19 to 2027-28 in the reference 5th cited. The District Educational Officer, Vizianagaram District has verified the application for Provisional Recognition with reference to the Inspection Report of the Inspecting Officer and as per G.O.Ms.No.1 Education, Dated.01.01.1994.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby accords Provisional Recognition for a period of **10 (Ten) years** i.e., for the academic years from 2018-19 to 2027-28 for the classes VIII to X (EM) as recommended by the Deputy Educational Officer, Vizianagaram and the District Educational Officer, Vizianagaram District without Grant –in-Aid now or in future subject to fulfillment of the following conditions in **Dr.Varalakshmi High School, T.Boddavara, S.Kota Mandal, Vizianagaram District.**

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
 - a. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No Objection Certificate. The same should be got renewed for the entire period of recognition.
14. The management informed that no thatched roof accommodation is allowed to run the School.
15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. That the management shall obtained and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.

25. That the Management of the school is informed to obtain the Occupancy clearance from the Fire services Department concerned for the entire period of recognition and submit the same to this office without fail.
26. The Management is informed to obtain and submit the Structural Soundness certificate issued by the Executive Engineer. R&B / P.R for the entire period of recognition without fail.

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed under the provision contained in the G.O 3rd above.
